Today every use of force incident is scrutinized frame by frame on a video and judged by untrained individuals (especially within our own organizations) creating distrust and false narratives. The use of force analysis, investigation, and training is a complex continually evolving issue. This 1-day training session is designed for Police Leaders who, review, report, instructor investigates police use of force incidents.
